2. Ed & An Inc., t/a Parole Liquors- 2125 Forest Drive, Annapolis, Maryland 21401

In accordance with the Article AB Annotated Code of Maryland, the Annapolis Charter and Code and the Rules Regulations of the Alcoholic Beverage Control Board of the City of Annapolis, this disciplinary hearing is in connection with Infraction **Citation 2026-00016893** which alleges the following:

10-2702- Selling or Providing Alcoholic Beverages to individuals under 21 Years:

- A. Prohibited. A person may not sell or provide directly or indirectly alcoholic beverages to An individual under the age of 21 years for the individual's own use or for the use of any other person.

7.12.370 - Minors—Sale or providing to:

- A. No person, either alone, or by a clerk, agent, servant or employee, directly or indirectly, shall sell, furnish, give, serve or deliver any alcoholic beverage to any person under the age of twenty-one years. Violation of this section shall be a Municipal infraction punishable by a fine as established by resolution of the City Council and shall be assessed against the person serving the alcohol to the underaged person.

3.05- Minor -----Sales or providing to:

- A. No Licensee, in person or by an agent or employee, directly or indirectly, shall

serve, sell, give or deliver an Alcoholic Beverage to a person who is under the age of twenty-one (21) years.
