All such Written Comment shall be dated and will identify the name and address of the person(s) or entity offering the Written Comment. The Agency shall vote to accept the Written Comment into the record of the meeting and the meeting record shall be so noted.

(Votes may be taken to accept Written Comments and to place them on record).

Public Hearings – Public hearings include the right of the public to comment, testify and submit materials to the Agency for its consideration subject to the same guidelines applicable to “Public Comment on Docketed Items only.” Items for Public Hearing are as follows:
