1. FY26 LOCAL APPROPRIATION REPORT – According to data as of 05/31/2026, 92% of the local appropriation has either been spent or is encumbered. In the coming weeks the business office will be processing journal entries for the planned budget offsets from School Choice and Circuit Breaker.
2. FOOD SERVICE ADMINISTRATIVE REVIEW – DESE conducted their required tri-annual administrative review of our Food Service program on April 14, 2026. As part of their review, it was identified that EPSD does not have a Meal Modification Policy in place. This is a requirement for participating in the National School Lunch Program. I am recommending that the policy subcommittee review the provided model policy from M. SC and develop a policy for EPSD.
3. SUMMER FOOD PROGRAM – This summer, we will be continuing to run our Summer Food Service Program for all interested families. The program will run out of Mountain View School. Meals will be available 5 days per week and must be consumed on-site. Information will be distributed to the community and an advertisement will be placed in the Daily Hampshire Gazette. The program will run from June 29 through August 14. Breakfast will be from 8:30 am - 9:15 am, and lunch will be from 11:15 am-12:30 pm.
4. EXERCISE OF OPTION FOR FOOD SERVICE CONTRACT EXTENSION – Our current contract with Chartwells as our food service management company (FSMC) included an initial three-year term for FY23, FY24, and FY25. The contract also included the option to extend the contract under the same terms for up to two additional one-year renewal periods. For this current school year (FY26), the School Committee voted to exercise the option for the first one-year renewal extension. I believe it is in the best financial interest of the district to extend the current contract. Therefore, I am requesting that the School Committee vote to exercise the option for the second one-year renewal extension for FY27.
  - a. Suggested Motion – Motion to approve exercising the option for the second one-year renewal extension with Chartwells for food service management for FY27.
5. YEAR-END TRANSFERS – In order to complete the year-end close, many budget transfers will be needed to zero out accounts and cover deficits. Some of these transfers will be larger than \$5,000.00.
  - a. Suggested motion: Motion to approve authorization for the Director of Business Services to complete budget transfers as necessary to balance and close out the FY26 budget.
6. PERSONNEL REPORT FOR MAY 2026 – There were no personnel changes for the month of May.

## AMENDMENT NUMBER FOUR

**THIS AMENDMENT NUMBER FOUR** effective July 1, 2026 is between the **EASTHAMPTON PUBLIC SCHOOLS** (the “School Food Authority” or “SFA”) and **COMPASS GROUP USA, INC.**, by and through its Chartwells Division (“Chartwells”) (collectively, the “Parties”).

WHEREAS, the SFA and Chartwells are Parties to a certain Food Service Agreement made as of July 1, 2022, as amended by that certain Amendment Number One effective July 1, 2023, as amended by that certain Amendment Number Two effective July 1, 2024, and as further amended by Amendment Number Three effective July 1, 2025 (collectively, the “Agreement”), whereby Chartwells manages the SFA’s food service operation and facilities; and

WHEREAS, the Parties now desire to amend the aforesaid Agreement;

NOW, THEREFORE, in consideration of the promises herein contained and for other good and valuable consideration, the Parties hereto agree as follows:

1. Section 2.1, Commencement and Term. This section is deleted in its entirety and replaced with the following:

**2.1** Commencement and Term. The term of this Agreement shall be for one (1) year beginning on July 1, 2026 and continuing until June 30, 2027 (“Term”) unless terminated by either Party as hereinafter provided. *7 CFR 210.16*

2. Section 10.3 Administrative Fee. This Section is deleted in its entirety and replaced with the following:

**10.3** Administrative Fee. Chartwells shall charge the SFA an Administrative Fee of ~~\$8,594.00~~ paid monthly during the 2026-2027 school year. Chartwells’ Administrative Fee represents its overhead expenses necessary to operate the Food Service Program including, but not limited to, area and zone supervision; and general support provided by Chartwells’ corporate offices, including without limitation, accounting, purchasing, tax, legal, research, auditing and other related administrative functions. The Administrative Fee shall be adjusted on the first day of each renewal term at a rate equal to the greater of the increase in the (1) Employment Cost Index, Private Industry, Compensation, Not Seasonally Adjusted – CIU201000000000A (“ECI”) and (2) Consumer Price Index- Food Away From Home (“CPI”) for the preceding year.

3. Section 10.4 Management Fee. This Section is deleted in its entirety and replaced with the following:

**10.4** Management Fee. Chartwells shall charge the SFA an Management Fee of \$817.00 paid monthly during the 2026-2027 school year. The Management Fee

shall be adjusted on the first day of each renewal term at a rate equal to the greater of the increase in the (1) ECI and (2) CPI for the preceding year.

4. Section 10.6 Guaranteed Surplus. This section is deleted in its entirety and replaced with the following:

**10.6 Guaranteed Surplus.** The FSMC guarantees that the bottom line of the operational financial report for the 2026-2027 school year (exclusive of cost of equipment repairs, maintenance, replacements, and smallwares) will be a surplus and result in no subsidy to the bottom line of the System. In the event that the costs (exclusive of cost of equipment repairs, maintenance, replacements, and smallwares) of operating the food service program exceed total revenues (from all sources), the FSMC will be responsible for any losses (shortfalls) incurred but in no event shall the reimbursement obligation exceed the annual Management Fee then in effect for the 2026-2027 school year (\$8,170.00). The Guaranteed Surplus and the FSMC's reimbursement obligation are based on the following conditions and assumptions. The Guaranteed Surplus shall be reduced to account for increased cost or loss of revenue by FSMC if the following conditions are not met during the school year:

CONDITIONS:

- The continuing accuracy of information provided by the System in the RFP, including value of USDA foods; cash and/or reimbursement levels from State and Federal sponsors; the number of students eligible for free and reduced price meals; and selling price of menu pattern meals and a la carte prices.
- Student enrollment of at least 1,411 and annual serving days for such students of at least 180 for breakfast and lunch.
- No changes in legislation or regulation (e.g., minimum wages, fringe and benefit taxes, unionization, etc.) that would impact cost of FSMC to provide the services.
- No strikes, work stoppages or school closings, and all make-up days due to inclement weather shall have at least equal sales revenue as a normal day of operation.
- Service hours, service requirements, type and number of facilities selling food and/or beverages on the System premises remain constant throughout the school year. The System shall limit the expansion of competitive food sales.
- Total operating costs will not exceed \$878,717.00.
- Any capital commitments are utilized as proposed. There will be no bad debts, including losses from uncollectible accounts.

5. Confirmation and Integration. Except as expressly amended by this Amendment, the parties hereby confirm and ratify the Agreement in its entirety. The Agreement, as amended hereby, constitutes the entire agreement between the parties and their predecessors pertaining to the subject matter of the Agreement, as so amended, and supersedes all prior and contemporaneous agreements and understandings of the parties and their predecessors in connection therewith.

6. Counterparts. This Amendment may be executed in any number of counterparts, each of which shall constitute an original and all of which together shall constitute but one and the same original document.

7. Headings. The section headings herein are for convenience only and do not define, limit or construe the contents of such sections.
