3. That Council authorize a reduction of development charges of up to 50% for the three-year period required under the DCRP, and authorize the CAO to determine the service categories where the reductions are most appropriate; and

That in the event the Town's application to the DCRP is successful, that Council authorize the CAO to assess the proposed terms of participation in the program, and to determine, in consultation with the Mayor and the board of InnServices (as required), whether to enter into a transfer payment agreement and to implement the development charge reduction proposed.

**By-law No. 063-26**

**A By-law of The Corporation of the Town of Innisfil to confirm the proceedings of the Council of The Corporation of the Town of Innisfil at its Special Council meeting held on June 15, 2026**

Whereas the powers of a municipal corporation are to be exercised by its Council, pursuant to Subsection 5(1) of the *Municipal Act, 2001*, S.O. 2001, c. 25, as amended ("*Municipal Act*"); and

Whereas the powers of every Council are to be exercised by by-law, pursuant to Subsection 5(3) of the *Municipal Act*; and

Whereas it is deemed expedient that the proceedings of the Council of The Corporation of the Town of Innisfil at this meeting be confirmed and adopted by by-law.
