



- III. Discussion and possible action regarding a change of the current golf course rates to include daily fee rates, weekend rates, and member rates-  
***(5:07 pm)- Kris Morin made a suggestion to change the current daily, weekend, and member rates to the following:***

**Effective May 1, 2025 (Daily Fee Changes):**

- ***Changing the 18 Hole Weekday Greens Fees to Monday-Thursday (It is currently Monday-Friday)***
  - ***Current Rate= \$24.00 (Includes Tax)***
  - ***New Rate= \$32.00 (Includes Tax)***
- ***Changing the 18 Hole Weekend Greens Fees to Friday-Sunday (It is currently Saturday and Sunday ONLY)***
  - ***Current Rate= \$29.00 (Includes Tax)***
  - ***New Rate= \$37.00 (Includes Tax)***
- ***Changing the 9 Hole Weekday Greens Fees to Monday-Thursday (It is currently Monday-Friday)***
  - ***Current Rate= \$16.00 (Includes Tax)***
  - ***New Rate= \$20.00 (Includes Tax)***
- ***Changing the 9 Hole Weekend Greens Fees to Friday-Sunday (It is currently Saturday and Sunday ONLY)***
  - ***Current Rate= \$19.00 (Includes Tax)***
  - ***New Rate= \$24.00 (Includes Tax)***

**Effective July 1, 2025 (Membership Rate Changes):**

- ***Single Membership:***
  - ***Current Rate= \$385.00 (Includes Tax)***
  - ***New Rate= \$405.00 (Includes Tax); this would be approximately a 5% increase***
- ***Couples Membership:***
  - ***Current Rate= \$475.00 (Includes Tax)***
  - ***New Rate= \$500.00 (Includes Tax); this would be approximately a 5% increase***
- ***Family Membership:***

- **Current Rate= \$550.00 (Includes Tax)**
- **New Rate= \$575.00 (Includes Tax); this would be approximately a 5% increase**
- **Each Additional Family Member:**
  - **Current Rate= \$125.00 (Includes Tax)**
  - **New Rate= \$130.00 (Includes Tax); this would be approximately a 5% increase**

**Effective July 1, 2025 (Trail Fee Rate Changes):**

- **Single Trail Fee:**
  - **Current Rate= \$75.00 (Includes Tax)**
  - **New Rate= \$85.00 (Includes Tax); this would be approximately a 15% increase**

**Effective July 1, 2025 (Shed Rental Fee Rate Changes):**

- **Single Shed Rental Fee:**
  - **Current Rate= \$175.00 (Includes Tax)**
  - **New Rate= \$200.00 (Includes Tax); this would be approximately a 15% increase**

***(5:15 pm)- Board member Andy Johnson made a motion to approve ALL rate increases, and Jim Lindeman seconded this motion, followed by all present board members in favor.***
